There's a fee for cash withdrawals, but none for paying by card in stores or online (apart from payments to gambling websites). Online statements are free. It costs £5 to get back any money loaded on your card. Remember that you may have to pay to top up your Orange Cash card in some places, including Post Office branches where it costs £1.50. You have to be over 13 to apply for an Orange Cash card. If you are under 18 years of age you must obtain permission from a parent or guardian. The £5 application is waived for this offer.
